Failure to maintain your garden in guideline with the garden rules and regulations will result in your eviction from the garden and the loss of your yearly rental fee AND deposit. NO REFUNDS of any kind are given. If you maintain your plot, at the end of the season, your deposit will be returned to you or used as the rental fee for next year.
